

I Emma Jane Preece of Auckland solemnly and sincerely make oath and swear as follows;

1. That is my full name.
2. I live in the Waikato with my husband Nick and our two children Millicent (milly) and Florence.
3. We have a third daughter, a half sister to our children named Jamie Preece who we have been alienated from for many years now by her mother.
4. This has caused our family much distress and unnecessary harm.
5. In August of 2016 our family attended the Hot Wave Cafe Open Mic Night so that our daughter Milly could Sing on stage.
6. We home school our children and as part of their curriculum Milly has Singing and Piano lessons and it was a boost to Milly's Confidence to sing on stage in front of an audience.
7. During one of these evenings at the Hot waves cafe we met Lisa and Simon from Germany and their two children Clara and Lottie.
8. Milly and Clara became friends and sang on stage together.
9. We met up with Lisa and Simon and their family several times at these Friday music nights.
10. Lisa told us that she had left Germany legally with her Daughter Clara and that she was on the Run from her Ex husband, who she described as violent, threatening and abusive towards her.
11. Lisa told me that her ex husband who I now know to be named Axel had run over Simons foot with his car injuring Simon in the process.

12. It was clear that Lisa was very distressed, was anxious and was not settled.
13. Lisa told us not to take any photos of Clara and to not post anything on Social Media.
14. On Saturday the 10th of September 2016, I attended a birthday party for Lotty at the Macadamia Nut farm where Lisa and Simon were living at the time.
15. Again during this time, Lisa again told me about the car accident where her partner had run over Simons foot.
16. On the 24th September 2016 we entertained Simon and Lisa at our home for our daughter Florence's Birthday and again Lisa told us her story.
17. During this time Lisa said to me that she felt her ex husband was going to MURDER her.
18. The next day Lisa and Simon and Lottie their naturally born sibling, left our home and yet left Clara in our care.
19. As a mother, I thought this very strange and not normal since we did not know them very well and I thought it disturbing that they left Clara at our home for over two hours.
20. I am concerned with Alienation of children from Fathers, since I have witnessed my husband Nick go through distress of this for over 14 years.
21. We have jointly attended every Family court ordered meeting, every mediation, every court appointed psychological assessment and have never seen our rights to see Jamie Preece supported and protected.
22. We love Jamie Preece, we would love to spend time with her and yet no one is enforcing the parenting orders we have for time with the child.
23. No one is protecting Jamie Rights to see her own father.
24. No one is protecting the child from known harm.
25. Parental alienation of Jamie from our lives is mostly complete now, since we did not see her at all this Christmas.
26. I have personally been exposed to the horrible antics of my husbands ex wife, who hated me, who always made our time with the child difficult, who was envious of me, who sent me horrible texts, who lied to me and who has

never made it easy for us to see Jamie.

27. I want the courts to hear this from a Mother, who is married to a good man, a good father who has been deliberately deprived time with his child - Jamie Preece.

28. Alienation and defending himself against false accusations, and protection order applications, destroyed my husband and his ability to earn high incomes.

29. My husband has for years been falsely accused by his ex wife of being Abusive, violent and threatening and yet there is no evidence of this ever.

30. I have lived with Nick for over 14 years and have never seen him violent, abusive or threatening to anyone.

31. Nick is a good father to his children and he has been deliberately gas lighted and character assassinated by his ex wife.

32. When we engaged with Sarah Calvert we were so happy we finally had someone on our side identifying the Parental Alienation of the mother from the Father.

33. We were then distressed and totally decimated when the Lawyer for Child ASHMORE hid this expert evidence from the courts, lied to the courts and protected the mothers actions.


34. When my husband was no longer able to pay maximums in child support at the insistence of his Accountant - since he was no longer earning a high salary - his business career destroyed by Alienation and false accusations.

35. IRD kept targeting us for Maximum payments when they knew my husband no longer earns maximums in income.

36. When we finally agreed with IRD to resolve all matters they breached contract, and raided our home and took my personal vehicle - the family car - which they had no right to take and which they had to return, dumping it in a paddock of our neighbours farm.

37. I have never received an apology from IRD since these unlawful raids on our home in 2012, while away overseas with the child Jamie Preece.

38. Before we left on this trip away, the mother held up the passports, caused all sorts of problems making our travel unpleasant and sent me horrible text messages to me before I boarded the plane.

39. Jamie Preece also missed the funeral of her grandfather Mike Preece after the mother took her away overseas to America, just before his anticipated death.


